By signing this form, I agree as follows:

1. I understand that participating in the SJCA Sports Clinic (Event) may expose my child to above normal risks of injury or harm. These risks include uneven or hazardous playing surfaces, physical contact or collisions with other players, spectators or inanimate objects on or about the court. I understand that the sport of basketball is in itself hazardous and may result in injury to me or other players. I represent that my child has no health or physical problems that will interfere with his/her participation in the Event and I agree that I am responsible for his/her safety.

2. I assume all risks associated with my child's attendance and participation in the Event. I understand that I am solely responsible for any injuries which may occur to me as a result of my participation in the Event and I specifically waive my right to bring litigation against the Saint Joseph's Catholic Academy (SJCA) and sponsors that may be affiliated with the Event, and their respective staff, volunteers, officers, directors, Board members, administrators, employees, agents, representatives, successors or assigns for any injuries or losses, and specifically release any right which I may have to assert a negligence or similar claim against the persons or entities identified in this paragraph.

3. I hereby fully and forever release, discharge, hold harmless and agree not to sue SJCA, any sponsors that may be affiliated with the Event, and their respective staff, volunteers, officers, directors, Board members, administrators, employees, agents, representatives, successors or assigns from and against any and all claims, causes of action or liability for any injury, loss or damage sustained or incurred by me arising out of or in any way associated with my attendance at or participation in the Event, including, without limitation, all claims, causes of action or liability arising out of the negligence of any persons or entities identified in this paragraph.

4. I agree to indemnify and hold harmless SJCA and any sponsors that may be affiliated with the Event, and their respective staff, volunteers, officers, directors, employees, agents, representatives or successors from any loss, damage or expense sustained or incurred by any them arising from any claims, causes of action or liability, resulting from my actions or conduct, anyone acting on my behalf, or anyone else because of conduct reasonably attributed to me.

5. I grant full permission to and for SJCA, its volunteers, representatives and employees to take photographs, video or other recordings of me and my property in connection with the Event. I authorize the SJCA, its assigns and transferees to copyright, use and publish the same in print and/or electronically. I agree that SJCA may use such photographs, video or recordings of me with or without my name and for any lawful purpose in any manner or publication, including for example such purposes as publicity, illustration, advertising, promotions, Web content or other trade or commercial purposes, without payment of any fee or any reimbursements of any kind due to me.

6. This Agreement, including the Release and Waiver, is and shall be binding upon my heirs, assigns, and representatives and any person or entity acting upon my behalf, including parents, guardians, or next of kin.

7. This agreement shall be construed and interpreted according to the laws of the Commonwealth of Pennsylvania.
